



# **Annual Report Summary**

**Fiscal Year 2007**

## **Accomplishments**

This year Coleman Professional Services has had many accomplishments that we are very proud of. Over the years Coleman has grown from a \$1 million company in Kent, Ohio to a \$20 million company that serves 5 counties. During 2007 Coleman, continued to raise the bar that has been set over the decades and achieved many of the goals that were set at the beginning of the year. The company was able to grow by expanding our infrastructure, number of clients and services offered as well as continue to grow our relationships with other organizations in the areas we serve. Over all it was a great year and should lay the foundation for a fantastic future.

The following are some highlighted achievements accomplished this year:

- Served over 11,000 individuals and families, which was an increase of 14% from FY06
- Raised our duplicate client count, one client receiving multiple services, to 22,000. This is an increase of 15% from FY06.
- Provided subsidies to clients with annual income of less than \$16,000 which was 73% of those served
- Start up of crisis and case management services in Trumbull county
- Opening of Joey's Landing in Trumbull County for the housing of persons who are homeless and have a severe and persistent mental illness.
- Canton Advisory Board established (names listed in "Board" Section).

- The Canton Advisory Council consists of 6 to 8 members, meeting four to six times per year, and was initiated in order to advise management and staff at the Coleman Canton office of specific community needs. The council will help the Canton office better accomplish Coleman Professional Services' mission in the area as well as recommend specific improvements to services.

It is because of our dedication that other organizations have recognized our work in the various fields that Coleman has involvement. We are always honored and thank all of those that have recognized us in 2007.
