Our Mission

It is the mission of Coleman Professional Services to improve the lives of people it serves regardless of their ability to pay. Coleman delivers mental health, substance use, residential and rehabilitation services. Coleman supports and empowers its employees through continuous improvement.

A Note From Nelson

Coleman continues to grow and serve the people in our communities through Fostering Recovery, Building Independence, and Changing Destinies.

Coleman's important benchmarks remain our focus in FY19. We served 31,317 children and adults in FY19; a 10% increase from FY18. Coleman also exceeded its goals in Job Placements and Residential Placements. A total of 826 employees (731 FTE) were contributing to Coleman's important mission which resulted in a 4.7% increase of employees.

Financially, Coleman remained focused on one of its key strategic goals: financial growth. Our financial year ended with gross revenues at \$58,023,566. Gross revenues increased for the year by \$6,447,951; we exceeded our strategic growth goal by \$2,308,580. The most significant factor in this growth was our "geographic expansion" sector of \$2.3 million. Medicaid redesign in Ohio remained one of Coleman's biggest challenges due to the requirement to work through managed care companies when billing Medicaid.

I continue to be grateful to both clinical and administrative staff for mastering the changes and ensuring a continuity of care to our clients.

Our Social Enterprise Division, including Coleman Data Solutions, Coleman Rental Management, Coleman Consultation, and Bean and the Baker are contributing to Coleman's bottom line. A new Behavioral Health Clinic was opened in Barberton, Ohio; providing Intensive Outpatient Programming and important addiction services. Coleman Crisis Services in Stark opened in August of 2018 after the original nonprofit, CIRC, had financial problems and could not sustain their mission. Contracts in Jefferson County were signed to operate a 6-unit

crisis beds program at the Trinity Hospital Systems. Renovations begin by June and should be operational by February 2020.

I am most proud of Coleman's continued focus on quality improvement and customer support. One client writes... "The part Coleman has played in helping me to grow as a person is really immense... Thanks to Coleman, I finally feel like I actually have a life." Our customer satisfaction continues to excel with 89% of our active clients responding in our independent study that "...Coleman has improved my life." As Coleman's leader we will continue to improve in our clinical services when treating children and adults with mental health and addiction services. We look forward to this next year in providing clinical "best practices" services to our customers.

2019 Year at a Glance

Significant Events of 2019

Coleman became the primary provider for Crisis Services in Stark County, providing mobile crisis services for youth and adults, as well as a crisis stabilization unit. This is a new spectrum of services for Coleman in Stark County.

The Barberton Clinic launched a full continuum of Substance Use Disorder services in the First Quarter of FY19, including an Intensive Outpatient Program (IOP), complemented by Medication Assisted Treatment, Individual Therapy and Case Management. Coleman Professional Services has quickly become an IOP provider of choice for the Barberton Court and the Addiction, Drug Addiction & Mental Health Addiction Hotline.

Opened Coleman's first therapeutic playscape at our Center of Excellence for Children and Youth. Designed by our own therapist, the playscape is comprised of hardscapes and landscapes to give children a fun and safe environment to express themselves.

Coleman Data Solutions was recognized for their incredibly high standards and level of professionalism. The SOC 1 Type 2 Attestation recognizes Coleman Data as a company that thoroughly trains employees and can be trusted to handle to most sensitive data and information.

Coleman achieved a three-year accreditation from the Commission on Accreditation of Rehabilitation Facilities (CARF). CARF is an independent accreditor of health and human services, specifically behavioral health and employment and community services.

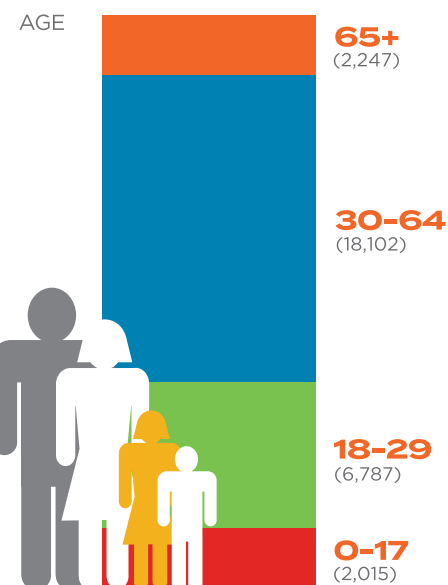

Gender and ages of those who use our services

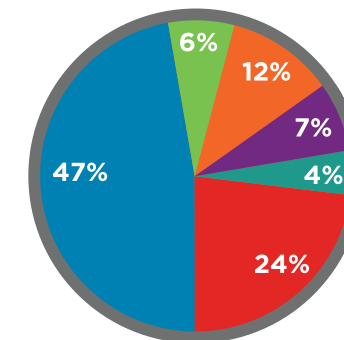

Over \$200,000

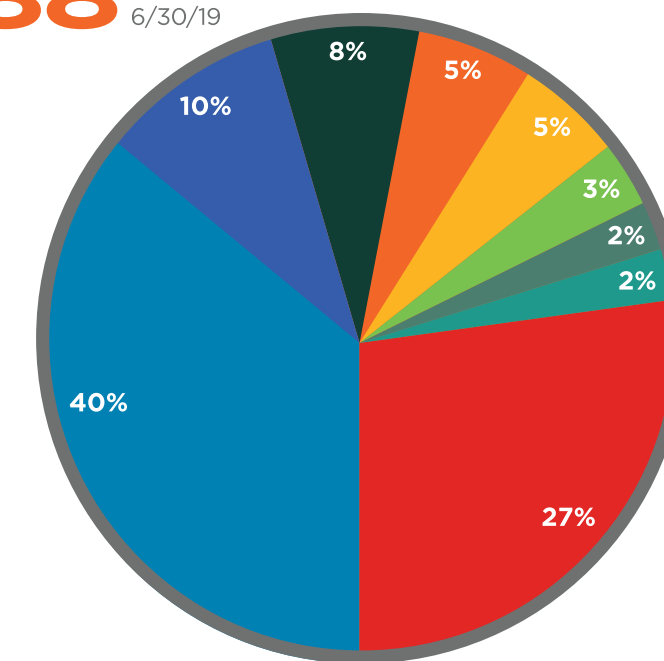

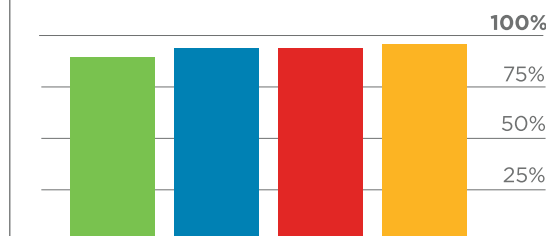

Programs include FIRST (treating first psychotic episode) and Embrace (helping addicted pregnant woman to overcome their addiction, in order to have healthier outcomes for themselves and their babies).

Residential Services – Build Independence

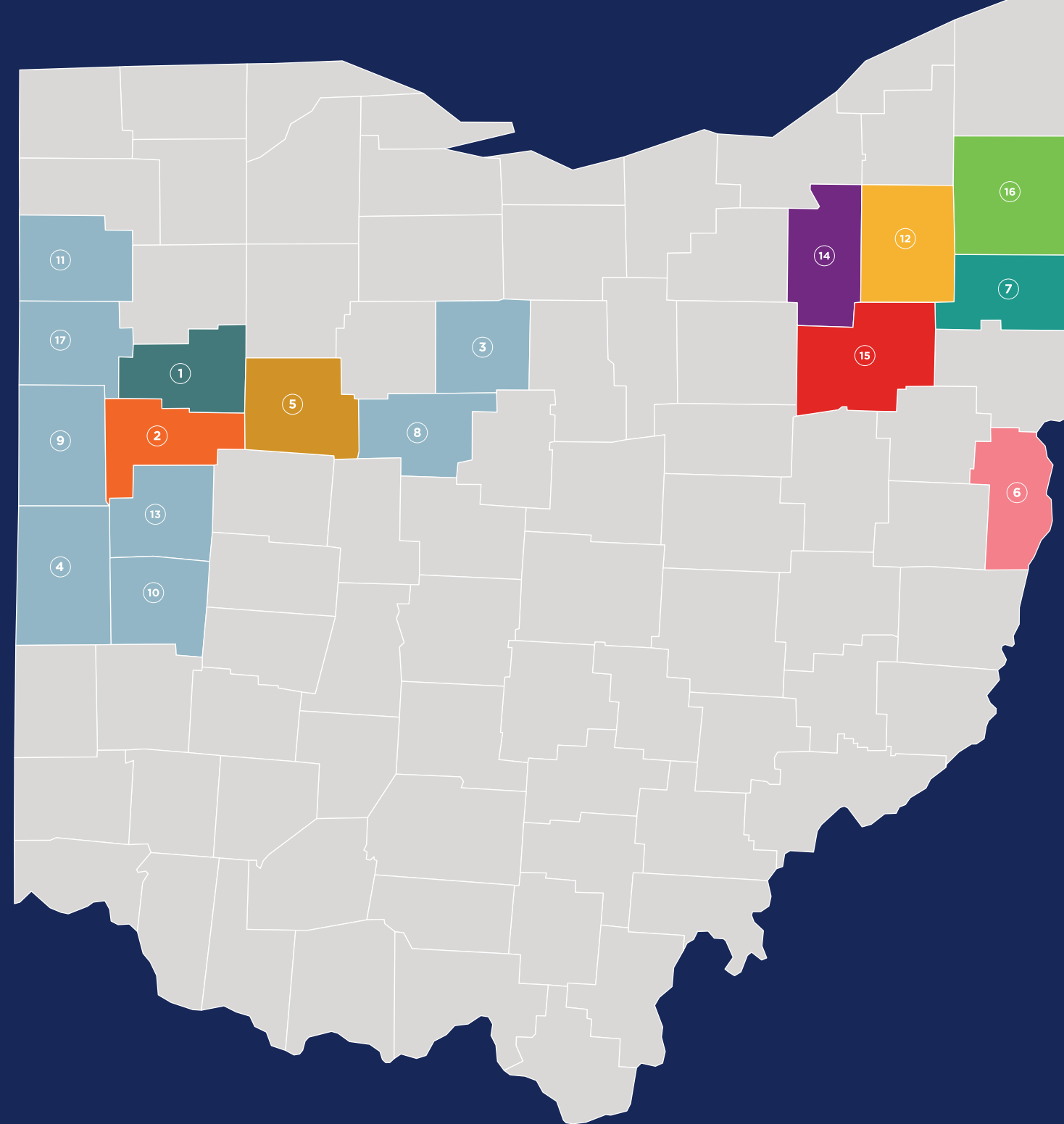
Housing assistance, group housing and youth transitional services that include apartment living, budget management classes and other programs that help prepare clients for independent living.

Supportive Services – Transform Lives

Mediation and conflict management, pregnancy, guardianship and family care – including adult day care services, eldercare case management, jail liaison support and adult protective services.

Employment Services – Change Destinies

Empower people to complete their education and build the skills they need to secure employment that matches their abilities. It includes job matching, assistance with interviewing, securing transportation and more.

Stark County Crisis Services One Year Later

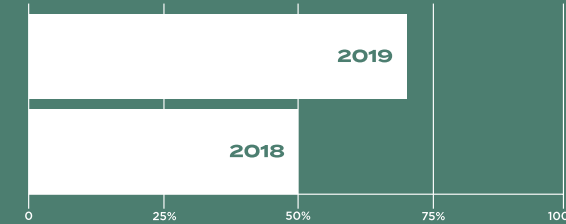
Since taking over the Crisis Intervention and Recovery Center (CIRC) in August of 2018, Coleman has been busy upgrading, renovating and growing the staff of what is now Stark County's leading, most comprehensive crisis center.

"We have been resilient in building the organization we believe will best serve the community," says Michelle Smith, Director of Coleman Crisis Services of Stark County.

She adds, "Growth and teamwork have also been critical to the sustainability of services rendered."

Remarkable Growth

The program renamed Coleman Crisis Services has marked many accomplishments in just over one year. **The Crisis Clients Served has increased from below 50% to 70%.**



To strengthen the staff and provide high quality care to the increased number of clients, **Coleman Crisis Services has hired fifty-six professionals.**

New Staff

In 2019 three new Directors were onboarded, completing the new Coleman Crisis Management Team. Brittany Reed joined as Director of Mobile Response, Tomika West joined as Director of Access, and Ashley Fuller as Director of the Crisis Stabilization Unit.

Continuing Education and Training

In April, several Coleman Crisis staff completed a 3-day training through International Critical Incident Stress Foundation to prepare them for participation in Stark County's Critical Incident Stress Management Response (CISM) Team. Since completing that training, staff have served as Team Leaders and/or community responders when critical incidents have occurred within the county, including debriefing about those events with other CISM team members and Stark County Mental Health and Addiction Recovery (StarkMHAR) staff.

Upgrades

The Crisis Stabilization Unit underwent significant renovations and a ribbon cutting was held on July 18, 2019 to celebrate the changes. Several community members including the Executive Director of StarkMHAR Board and the Mayor of Canton were present.

Students Raise Awareness & Money

The Mobile Response Team received over \$5,000 from Perry High School's inaugural Speak Life Resiliency 5k in the Spring of 2019. The second annual Speak Life Resiliency 5k benefiting Coleman Crisis Services takes place on April 26, 2020. The event is run by Massillon Perry High School students to help raise awareness of suicide prevention efforts while benefiting Coleman Professional Services' Youth Mobile Response team in Stark County.

Additional Community Support

Stark County Mental Health and Addiction Recovery (StarkMHAR) supports community services provided by Coleman Crisis. StarkMHAR always welcomes Coleman's insights that can lead to improvements in the region's crisis services.

Walsh University recognizes the value Coleman Crisis brings to the community and to future behavioral health professionals. Walsh is talking with Coleman about developing an internship program.

Spreading Awareness

Coleman professionals themselves were the best champions of our cause throughout 2019. Several Coleman Crisis staff joined Gary Rivers on WHBC in Canton to discuss the array of services offered through Coleman Crisis. Michelle Allison-Smith appeared on WKYC-TV's Live on Lakeside to discuss Coleman Crisis and how crisis management is integral to overall wellness and functioning across all domains, including employment.

Through all of this support, intentional growth and promoting the mission, the end result is better crisis response services for Stark County.

"Our goal is to increase the number of Stark County residents we serve, expand upon the services offered, and become an increasingly self-sustaining entity," says Michelle Allison-Smith.

Embrace program empowers pregnant and postpartum women to address opiate use

Using medication assisted treatment and other behavioral health and recovery services, Coleman began the Embrace Program in 2019 to help women who are pregnant and postpartum with opiate use disorder (OUD). Embrace mostly serves residents in Allen, Auglaize and Hardin counties. Embrace operates in partnership with Mercy Health in Lima and is partially funded by a grant from the Ohio Department of Mental Health and Addiction Services (OhioMHAS).

Coleman Adult Day Upgrades

Coleman Adult Day Services added updated amenities such as a new refrigerator and seating, supported by funding from the Northern Ohio Golf Charities and the first ever Kids 4 Coleman Jingle & Mingle event – a fundraiser founded by the Mandalari families. The 2019 event was held at Joyce and Jim Bowen’s beautiful home in Pambi Farm Estates. Funds raised through sponsorships and donations that evening will help defray the cost of daily care for those in need, regardless of ability to pay.



Transitional Age Youth Apartments Open in Kent

On May 15, 2019 in Kent, a ribbon cutting welcomed ten new apartments specifically built for Transitional Age Youth (TAY). Coleman’s youth transitional services assist youth and young adults with emotional and/or behavioral difficulties in their transition to adulthood.

Perry High Students Help Mobile Response Team

Perry High School students formed the Speak Life Committee and held a 5K run in spring, 2019. This raised funds for Coleman and awareness to bring connectedness, healing and hope to the community following a cluster of suicides the previous year. The committee received the Community Champion Award from StarkMHAR and the Youth in Philanthropy Award from Association of Fundraising Professionals (NE Ohio chapter).



Coleman Crisis Center Grows

After assuming management of the Crisis Intervention & Recovery Center in 2018, Coleman added new directors and management, and significant renovations, culminating in a July 18, 2019 ribbon cutting. (For more details, see story on page 9.)

New TAY Apartments Ribbon Cutting

May 29, 2019 Coleman held a ribbon cutting for the renovated transitional aged youth (TAY) Apartments in Massillon. The apartments provide a safe, supervised living space to stabilize, set goals and work toward independence. Services include vocational support, skill building, mentoring and coaching, and counseling. This gives young homeless adults with no support system a safe, affordable home and opportunities to learn life and job skills.

After moving to Ohio to pursue a relationship, Michael suffered severe trauma, became homeless and found himself in the depths of the court system. Michael received help and support from the HOPE court rehab program and Coleman Professional Services. He rebuilt his life through recovery, counseling, and skills training. Coleman Expands its Summit County Footprint

Barberton's Drug and Mental Health Courts

In 2019, Coleman opened a new Medication Assisted Treatment (MAT) program in Barberton, plus an Intensive Outpatient Program (IOP), and Aftercare services. Also, Coleman was awarded grant dollars from the Tuscora Park Foundation to Barberton schools to provide truancy mediation and family engagement services.



Mental Health Treatment in Summit

Coleman became a Charter member of the new Mental Illness and Intellectual Disability (MIID) team in Summit County. We also opened two more Easy Access Clinics, offering increased psychiatry capacity.

New Day and Hope Courts in Akron

Coleman facilitated the first psychoeducational group for newly resettled refugees, offering behavioral health information and resources. Coleman also supports Hope Courts. (See success story to the left.)

New Specialty Treatment Modalities

Our new offerings include: Art Therapy, Biofeedback, Eye Movement Desensitization Reprocessing (EMDR), and Trauma Informed Therapy

Traditions & Convenience

The tradition continued in Trumbull County in 2019 with the third Annual Coleman Cup golf outing held at Cranberry Hills Golf Course.

2019 marked the first year that Coleman offered services in a consolidated facility in downtown Warren after more than a decade of services spread across the county. This allows clients to arrange appointments with multiple providers in one visit. That convenience reduces scheduling and transportation issues. It is also more efficient for Coleman staff to communicate and collaborate in order to better provide high quality, comprehensive services to our clients.



Success Story

“I know I’m going to do it, it’s just a matter of when.”

On October 2, 2019 a distressed 39-year-old woman with a history of sexual abuse, binge drinking and homelessness, staying with her sister, called the National Suicide Prevention Lifeline and was directed to a staff member from Coleman. The caller expressed despair and the staff member on the phone listened, supported and gained the caller’s trust. The caller reported that she had thought about killing herself every day since she was 8 years old. With her birthday looming she stated, “I know I’m going to do it, it’s just a matter of when.” The staff person engaged in a long dialogue about a plan for her future. The caller stated, “I don’t know what tomorrow holds, but I want you to know I’m safe for today. No one has taken the time to listen to me in the way you did today.” The caller began to cry and repeatedly thanked the staff stating that she would call back if it got to be too much again.

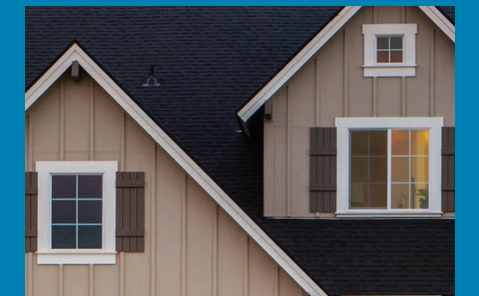

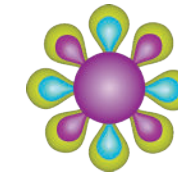
